**Sub:- Continuance of recognition of MBBS degree granted by Kerala University of Health & Allied Sciences, Thrissur (Previously University of Calicut) in respect of students being trained at Amala Institute of Medical Sciences, Thrissur, Kerala -reg.**

Sir/ Madam,

I am directed to inform that Compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Kerala University of Health & Allied Sciences, Thrissur (Previously University of Calicut) in respect of students being trained at Amala Institute of Medical Sciences, Thrissur, Kerala was carried out by the Council Assessors on (10<sup>th</sup> February, 2016). The compliance verification assessment report (10<sup>th</sup> February, 2016) along with the previous compliance verification report (6<sup>th</sup> July, 2015) and the previous assessment report (2<sup>nd</sup> & 3<sup>rd</sup> September, 2014) was considered by the Executive Committee at its meeting held on 27.02.2016. The following recommendations of the Executive Committee <sup>was</sup> approved by the General Body of the Council at its meeting held on 30<sup>th</sup> March, 2016 :-

*"The Council approved the following recommendations of the Executive Committee:*

*"The Executive Committee of the Council considered the compliance verification assessment report (10<sup>th</sup> February, 2016) along with the previous compliance verification report (6<sup>th</sup> July, 2015) and the previous assessment report (2<sup>nd</sup> & 3<sup>rd</sup> September, 2014) and decided to recommend that recognition of MBBS degree granted by Kerala University of Health & Allied Sciences, Thrissur (Previously University of Calicut) in respect of students being trained at Amala Institute of Medical Sciences, Thrissur, Kerala be continued restricting the number of admission to 100 (One Hundred) students."*

The Council further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute..."



Sir,

In continuation to this Ministry's Letter of Intent of even number dated 27.6.2003 and with reference to your letter dated 27.6.03, I am directed to convey the approval of the Central Government to the establishment of a new medical college in the name and style of “Amala Institute of Medical Sciences” at Trissur, Kerala by Amala Cancer Hospital Society, Trissur, Kerala with an annual intake of 100 (one hundred only) students with prospective effect i.e. from the academic session 2003-04 Under Section 10(A) of IMC Act, 1956 as amended.

2. This permission of the Central Govt. for establishment of the college and admission of students is initially for a period of one year. It will be renewed on yearly basis on verification of achievement of annual target set out in the project report. This process of annual renewal of permission will continue till such time the establishment of medical college and expansion of hospital facilities are completed as per norms of Medical Council of India. The college shall not admit more than one batch of students against this letter of permission. The college shall also apply to Medical Council of India for renewal of permission well before the commencement of next academic session. While applying for such renewal, the achievement in terms of infrastructure, staff and equipment as spelt out in the time bound action plan and as required by Medical Council of India norms must be clearly indicated. The next batch of students shall not be admitted unless renewal of permission is granted by the Central Government.
