In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Biochemistry) qualification for 02 seats in respect of students being trained at Amala Institute of Medical Sciences, Thrissur under Kerala University of Health Sciences, Thrissur**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*

2. The approval for Renewal of Recognition of MD(Biochemistry) qualification for 02 seats is granted subject to applicability of amendments in NMC Regulations from time to time.

3. **As per the Assessor's report, there are certain deficiencies. You are directed to take corrective steps and rectify the deficiencies and inform the Postgraduate Medical Education Board of NMC within six months from the date of issuance of this letter.**

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (28th July, 2016) on the physical and other teaching facilities available at Amala Institute of Medical Sciences, Thrissur for the award of MD(Biochemistry) qualification for 2 seats under Kerala University of Health Sciences, Thrissur. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (28th July, 2016) and decided to recommend to the Central Government that MD(Biochemistry) qualification for 2 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Amala Institute of Medical Sciences, Thrissur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
